ORDER:

As per rule 12 (2-A) (f) of the Tamil Nadu Minor Mineral Concession Rules, 1959, permission is granted for a period not exceeding three months for quarrying silt, savudu and gravel from the beds of tank under the control of Public Works Department or Rural Development and Panchayat Raj Department for other than bonafide domestic or agricultural purposes. Considering the issues faced by the National Highways Authority of India / State Highways Department etc., while implementing their projects in Tamil Nadu, the Government have decided to give permits for a period not exceeding one year in Government lands.

2. Accordingly, the Notification appended to this Order will be published in the Tamil Nadu Government Gazette Extraordinary. The Works Manager, Government Central Press, Chennai - 600 001 is requested to supply 50 copies of the Notification each to this Department, Director of Geology and Mining, Chennai - 600 032 and to all District Collectors.

3. The Director, Tamil Development and Information (Translation) Department is requested to send the Tamil Translation of the Notification appended to this Order to the Works Manager, Government Central Press, Chennai - 600 001 for publishing in the Tamil Nadu

APPENDIX.**NOTIFICATION.**

In exercise of the powers conferred by section 15 of the Mines and Minerals (Development and Regulation) Act, 1957 (Central Act 67 of 1957), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Minor Mineral Concession Rules, 1959: -

AMENDMENT.

In the said Rules, in rule 12, in sub-rule (2-A), to clause (f), the following proviso shall be added, namely: -

"Provided that for any bona fide public purpose including the projects of National Highways Authority of India or State Highways or Railways, the period of permission shall not exceed one year."
